Sub: Public Services – Bribery is against Law - Display of slogan containing "Bribe giving and receiving is an offence" Notice Board in all the offices and in public places at visible points – Reiteration of instructions – Follow up scrupulously – Regarding.

In the Government Order first cited, the Departments of Secretariat were requested to issue necessary instructions to the Head of Departments / Local Bodies / Public Sector Undertakings directing that a Notice Board be displayed in every office and in public places at visible points, containing the slogan "*Bribe giving and receiving is an offence*", with the address and phone numbers of the Directorate of Vigilance and Anti-Corruption.

2. In the Government references from second to fifth cited, detailed instructions on the above subject have been issued from time to time.

3. Now, Instances are brought to the notice of the Government that the orders / instructions issued by this department in this regard were not scrupulously followed in some offices / departments and the notice boards were not displayed prominently at public visible points.

4. Hence, it has been decided to issue consolidated instructions on the above subject and accordingly the following instructions are issued:

(a) all the Departments of Secretariat and all the Heads of Department, all Collectors, District level officials are requested to display a Notice Board in English and in Tamil, in every office, in public places at visible points, also in website containing the following slogan:-

*"Bribe giving and receiving is an offence",

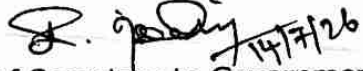
(c) All the Departments of Secretariat, Head of Departments, Subordinates, Local bodies, Government Company or undertaking are requested to post the message in (a) above in their official website, with a link to the Directorate of Vigilance and Anti-Corruption portal.

(d) The Inspection Wings and the Inspection Cell in the District Collectorate are also instructed to inspect the Government Offices whether the above instructions are properly implemented.

5. Further, all the Departments of Secretariat and all the Heads of Department are also requested to send the compliance report to the Human Resources Management (N) Department after ensuring that the said instructions are complied upon in all the offices / Boards / Corporations / Local Bodies / Public Sector Undertakings under their control.
